Principles of awarding grants of the University of Economics in Bratislava to young teachers, researchers and doctoral students in full-time study

Internal directive Principles of awarding grants of the University of Economics in Bratislava to young people teachers, researchers and doctoral students in full-time study no. 8/2019, which entered into force on August 23, 2019, is amended as follows:

1. in Article 8 point 4:

• the wording "according to the conditions of the granted grant" is deleted and replaced in the wording: "if in the Results of the research project (Appendix No. 3A) shall state the purpose of using these funds and observe the drawing in accordance with this purpose"

2. in Article 10 point 1:

- the wording is inserted after the first sentence: "The final report is prepared on the basis of of the prescribed form (Appendix No. 3)."
- wording "The following attachments are part of the report: list of publication outputs according to the EPC database of the Slovak Economic Library (articles in journals, proceedings, abstracts from conferences, etc.), a list of publication outputs submitted to the press, copies of the five most important outputs." is changed to: "The following appendices are part of the report: Results of the research project (Appendix no. 3A), list of publication outputs according to the EPC Slovenská database economic library (articles in magazines, proceedings, abstracts from conferences etc.), a list of publication outputs submitted to the press together with confirmation of their acceptance (e.g. by e-mail), list of publications outputs sent for publication together with confirmation of their sending (e.g. by e-mail), copies of the five most significant outputs."

3. in Article 10 point 2:

- designation "Appendix no. 3" is changed to: "Annex no. 4"
- 4. "Annex no. 3" is renumbered to "Annex no. 4", while the wording of point 4 in the new Appendix no. 4 changes to:

"4. Evaluation of project outputs*

- Be in a journal indexed in Web of Science or SCOPUS (ADC, ADD, ADM, ADN): 8 b**
- Stand in a journal not indexed in Web of Science or SCOPUS (ADE, ADF): 4 b**
- Be sent to a journal indexed in Web of Science or SCOPUS: 4 b
- Be submitted to a journal not indexed in Web of Science or SCOPUS: 2 b
- Domestic/foreign monograph, or chapter in monograph domestic/foreign (AAA, AAB, ABC, ABD): 4 b**
- Article in conference proceedings indexed in Web of Science (AFC, AFD): 4 b**

- Other scientific and professional works: 2 b",while the character "**" is interpreted as: "Consider only with publication outputs registered in the SEC or submitted to the press (only on the basis of confirmation of their acceptance).'
- 5. "Annex No. 3" and "Annex no. 3A"

New attachments no. 3, no. 3A form an appendix to this appendix.

Other points of the Internal Directive no. 8/2019 remain unchanged.
