

## Internal Regulation No. 6/2020

### Accommodation Fees in the student dormitories of the University of Economics in Bratislava

I determine fees for the accommodation of students<sup>1</sup> and employees in student dormitory of the University of Economics in Bratislava (hereafter SD UE in Bratislava) with effect from 1. August 2020 as follows:

#### Article 1

1. The amount of monthly fees for the accommodation for students and employees and other types of accommodation during an academic year. Prices for employees, guests of the UE in Bratislava and other persons who might be interested are quoted inclusive of VAT. Student accommodation is provided in compliance with the Act No. 222/2004 Coll. exclusive of VAT.

## 2. Other Types of Accommodation

- Business trips of employees of the UE in Bratislava (Faculty of Business Economics, residence in Košice ) - to provide free accommodation.
- Short term accommodation for employees of the UE in Bratislava and members of their families – 9,00 Eur/person/night with VAT
- Accommodation of other persons – subject to operating conditions and to Director's approval as follows:

### 3. Accommodation at Special-purpose Facilities of the UE in Bratislava

Prices for accommodation in these facilities are quoted pursuant to specific regulations.

### 4. Terms and Conditions and Method of Payment

- a) **Employees** – accommodation fee without regard to the date of arrival and check-out is a monthly payment as per permission on accommodation. Employee is paying accommodation fee to the 15<sup>th</sup> of the corresponding month by way of deduction from wages under the "Agreement on wage deductions."<sup>6</sup>
- b) **Students** – accommodation fee without regard to the date of arrival and check-out is a monthly payment as per permission on accommodation. **The student has to pay the accommodation fee in advance by the 25th day of the relevant month for the following month** by non-cash payment to the bank account of SD UE in Bratislava with right variable symbol. The name and surname of the accommodated student shall be given in a message for the addressee.

## **5. Utilizing Electrical Appliances**

Utilization of electrical appliances in separate student dormitory is specified by a relevant internal regulation of the Center of business activities and university service UE in Bratislava.

- 6. Accommodation fees at SD UE in Bratislava during summer holiday** (from 1 July to 31 August) is determined by a relevant internal regulation of the Center of business activities and university service UE in Bratislava.

### **Article 2**

- SD UE in Bratislava are obliged to pay tax for accommodation amounting to 1,70 Eur person/night to Bratislava – capital of the Slovak republic pursuant to § 37 and Act No. 582/2004 Coll. on local taxes and local fee for community wastes and small construction wastes as amended and General Binding Directive of the capital of the Slovak Republic – Bratislava No. 8/2016 of 30 June 2007 on accommodation tax. Accommodation fee shall be increased by this amount. A person, tax-free is a student under the age of 26.
- SD UE in Bratislava J. L. Bellu PHF in Košice are obliged to pay tax for accommodation amounting to 1,50 Eur person/night to § 37 and Act No. 582/2004 Coll. on local taxes and local fee for community wastes and small construction wastes as amended and General Binding Directive of Košice No. 104 on accommodation tax. Accommodation fee shall be increased by this amount. A person, tax-free is a student under the age of 26.

### **Article 3**

- Hereby the Internal Regulation No. 3/2019 on the 17. April 2019 are canceled.
- This regulation comes in force on the 1. August 2020.
