FACILITIES AND STUDENT LIFE

- The main campus in Bratislava – Petržalka is a modern complex which meets all requirements that are necessary for teaching and research, as well as for catering, accommodation and physical activities of students. Lecture halls, classrooms, laboratories, computer rooms, special language classrooms, library, bookshops etc. are available.
- The University provides accommodation for its students in dormitories situated directly on the main campus, just off the campus and throughout the city. University is able to house approximately 3,500 students. The quality of accommodation is of standard level or higher standard level (3-1 bed per room). From the dormitories outside the main campus there are good transport connections to the main campus.
- Student meals are provided on the main campus in a self-service dining hall with a wide selection of hot meals. There are also several cafeterias and snack bars providing fast food, as well as vending machines with hot and cold drinks.
- The Buddy system is a student organisation that helps new students from abroad to become accustomed to life in Bratislava.
- The Slovak Economic Library has a wide collection of books, periodicals, e-books, e-journals and databases. Computer rooms throughout the University are used for the teaching process and they are available to students for individual work as well. The whole campus is covered by wi-fi access points, enabling students to go online wherever they are on campus.
- Students may take part in a wide range of physical activities offered by the university in its residential and other sport facilities (football, tennis, table tennis, swimming, aqua aerobic, indoor football, volleyball, basketball, handball, badminton, skating, inline skating, floor-ball, aerobics, step-aerobics, fitball aerobics, body work, power-yoga, Pilates, fitness bodybuilding). In summer and in winter various trainings are organized (in winter – downhill and cross-country skiing, snowboarding; in summer – hiking, rafting, camping).
- Students can join AIESEC, the world's largest youth organization, which is present in over 2,100 universities in 110 countries.

The graduate is able to manage large groups of people, he/she is able to rapidly adapt and acquire industrial, cultural and regional peculiarities. Graduates find career placement mainly in positions of line managers at middle and senior levels of the business. There is the possibility to participate in double degree program with the University of Strasbourg, France.

She/he gains comprehensive knowledge of modern economic theories and modern financial theories. He/she is equipped with knowledge and skills in the use of advanced analytical techniques, methods of analysis and prognosis in international finance. There is the possibility to participate in joint degree programme with the Nottingham Trent University, UK or double degree with the NIDA, Thailand.

Core courses (selection): Microeconomics, Operations of Commercial Banks, International Finance, Financial Econometrics, Financial Accounting, Macroeconomics, Financial Programming, Capital Structure of Enterprises, International Taxation, Monetary Analysis and Prognosis, Financial Control, Seminar in Finance, Analysis and Prognosis in Finance, Public Finance, Tax Theory and Policy, Finance of Territorial Units, Risk and Uncertainty in Finance, Valuation of Financial Assets.

Degree: Graduates are awarded a diploma of the UEBA with academic title Engineer (corresponding to Master of Science) and there is a possibility to obtain a diploma with academic title Master of Science from the University of Economics in Bratislava and Nottingham Trent University or NIDA, Thailand.

They are qualified to work in central bodies of the state administration, international organisations, enterprises with foreign property participation, domestic companies, media in which they focus on issues of international relations and international economic relations.

Core courses (selection): Diplomatic Protocol, Economy of the EU States, Cultures in International Relations, International Trade Finance; Law of the EU, Diplomatic and Consular Law, International Economic Relations, International Political Relations, Law in International Economic Relations, Economy of Developing Countries, Communication in Diplomatic Practice, WTO – case studies, The Current Issue of the European Union, Development and Management of Projects.
