INTERNAL REGULATION

Centre of business activities and university service University of Economics in Bratislava (EUBA)

Principles of using electrical appliances brought by the accommodated to the dormitories in EUBA (hereafter SD EUBA)

- 1) Accommodated persons can use their electrical appliances brought in the SD EUBA under the following conditions:
- a) Without an application for permission to use their own electrical appliances:
 - **computer technology** (hardware) computer, laptop, monitor, printer, copier, scanner, computer power cord,
 - **electronics devices** radio, TV, iron, small electrical appliances hair dryer, razor, curling iron, flat iron, hair straightener,
 - **kitchen electrical appliances** coffee maker, toaster, blender, sandwich maker, rice cooker, fan.
- b) Upon request for written consent of the Director SD EUBA
 - **kitchen electrical appliances** one microwave oven per room, one refrigerator & freezer per room max 120 l capacity, energy efficient A), see Attachment No. 1 to this Internal regulation.
- 2) In SD Bellova Košice, it is not allowed to use a refrigerator and a microwave oven.
- 3) For the purposes hereof, a brought electrical appliance means any electrical appliance that is not in the register of assets of the SD EUBA and which is owned by student or employee EUBA. Any accommodated person is obliged to take away all such own electrical appliances no later than on the day of termination of the accommodation.
- 4) Accommodated persons are liable for:
 - any damages that occur because the technical condition of the brought electrical appliance was not in accordance with the safe operation,
 - safe connection to the electrical network,
 - safe use.
- 5) Accommodated persons are obliged to pay for damage caused by electrical appliances or remove them in full on his own.
- 6) The Director of SD EUBA is authorised to limit or cancel the use of electrical appliances, referred to in paragraph 1) of this Internal regulation, due to:
 - fulfilment of contract obligations towards the electricity supplier when declaring regulatory stages,
 - exceeding the capacity of consumption points technical maximums of resources, in this case in SD Bellova Košice, it is not allowed to use a refrigerator and a microwave oven,
 - during the inspection of the room, it is found that electrical appliances do not meet allowed technical parameters for safe operation, or the used electrical appliance has an inadequately high energy input.
- 7) It is forbidden to use the following electrical appliances in the SD EUBA:
 - direct electric appliances such as mobile electric radiators, hot air heaters, convectors, infrared heaters, and appliances of a similar character or type,
 - small heat appliances such as cookers, infra grills, electrical baking pan, and appliances of similar nature,
 - therapeutic and medical devices such as electric pillows, blankets, pads, infrared lamps and appliances of similar nature.
