**Accommodation Fees in the student's dormitories of the
Bratislava University of Economics and Business**

The Rector of the Bratislava University of Economics and Business (hereinafter also referred to as the “EUBA”) issues this Internal Regulation “Accommodation Fees in the student’s dormitories of the Bratislava University of Economics and Business”.

Article 1

Accommodation Fees for Students and Employees of EUBA

The amount of accommodation fees for students and employees in student dormitories of EUBA (hereinafter also referred to as “Dormitories”) during the academic year is as follows¹:

Self-contained Accommodation	Fee per person/month in EUR
Self-contained accommodation in a 1/1 unit may be granted upon request. The monthly fee for such a room is set according to the price list applicable to all accommodation facilities. This type of accommodation can be provided only if there are available capacities.	165,00
Self-contained accommodation in a 1/2 unit may be granted upon request. The monthly fee for such a room is set according to the price list applicable to all accommodation facilities. This type of accommodation can be provided only if there are available capacities.	180,00

⁹ Unit 1/1 – the unit consists of 1 single room with 1 bed, a bathroom (toilet and shower), and a kitchen

¹⁰ Unit 2/1 – The accommodation unit comprises two single rooms (one bed in each room), a shared sanitary facility (toilet and shower), and two shared kitchens located on the floor.

¹¹ Unit 1/2 – The accommodation unit comprises one double room (with two beds), a separate kitchen, and a private sanitary facility (toilet and shower).

Article 2 Accommodation Fees for guests of EUBA

The accommodation fees for EUBA guests (participants of conferences, congresses, seminars, business meetings, and other events organized by EUBA, if their stay is related to the activities of EUBA) in the student dormitories of EUBA during the academic year are as follows:

Article 3 Short-Term Accommodation for students of Slovak Universities

The accommodation fees for short-term stays of students from Slovak universities and higher education institutions, approved by the accommodation department of the respective student dormitory and provided for a maximum of two consecutive nights, are as follows:

Short-term accommodation for students from the Slovak universities which is agreed by the accommodation department of the Dormitories	
Fee per student/night	5,00 EUR
Fee per student/night, if the accommodated student to let the visit/student stay overnight in the room without previous approval by the accommodation department of the relevant Dormitories	10,00 EUR

Article 4 Fees for other types of accommodation

The fees for other types of accommodation in the dormitories of EUBA are as follow:

Article 5

Terms and payment methods

Employees – accommodation fee without regard to the date of arrival and check-out is a monthly payment as per permission on accommodation. Employee is paying accommodation fee to the 15th of the corresponding month by way of deduction from wages under the "Agreement on wage deductions."¹²

Students – accommodation fee without regard to the date of arrival and check-out is a monthly payment as per permission on accommodation. **The student has to pay the accommodation fee in advance by the 25th day of the relevant month for the following month** by non-cash payment to the bank account of Dormitories with right variable symbol. The name and surname of the accommodated student shall be given in a message for the addressee. The first accommodation fee is paid by the student within the term specified in the Accommodation Schedule for the relevant academic year.

Article 6

Other provisions

1. Dormitories are obliged to pay tax for accommodation amounting to person/night to Bratislava – capital of the Slovak republic pursuant to § 37 and Act No. 582/2004 Coll. on local taxes and local fee for community wastes and small construction wastes as amended and General Binding Directive of the capital of the Slovak Republic – Bratislava.
2. Dormitory J. L. Bellu PHF in Košice is obliged to pay tax for accommodation amounting to person/night to § 37 and Act No. 582/2004 Coll. on local taxes and local fee for community wastes and small construction wastes as amended and General Binding Directive of Košice.

Article 7

Final provisions

1. This internal regulation enters into force on the date of signature and takes effect on September 1, 2026.
2. Upon the entry into effect of this internal directive, Internal regulation No. 1/2025 of July 9, 2025, is hereby repealed.
