Accommodation prices in mass actions will be determined individually (with the agreement of the Director of the Center of business and university services University of Economics in Bratislava).

**In August, accommodation will be provided only until 24, August** (cleaning rooms). After this date accommodation is possible in justified cases only with the consent of the Director of the Center business activities and university service.

SD UE in Bratislava are obliged to pay tax for accommodation amounting to 1,70 Eur person/night to Bratislava – capital of the Slovak republic pursuant to § 37 and Act No. 582/2004 Coll. on local taxes and local fee for community wastes and small construction wastes as amended and General Binding Directive of the capital of the Slovak Republic – Bratislava No. 8/2016 of 30 June 2007 on accommodation tax.

SD UE in Bratislava J. L. Bellu PHF in Košice are obliged to pay tax for accommodation amounting to 1,50 Eur person/night to § 37 and Act No. 582/2004 Coll. on local taxes and local fee for community wastes and small construction wastes as amended and General Binding Directive of Košice No. 104 on accommodation tax.
