**Accommodation is not provided during the last week of August** (cleaning rooms). After this date accommodation is possible in justified cases only with the consent of the Director of the Centre of business activities and university service, Bratislava University of Economics and Business.

SD EUBA are obliged to pay tax for accommodation pursuant to § 37 and Act No. 582/2004 Coll. on local taxes and local fee for community wastes and small construction wastes as amended and General Binding Directive of the capital of the Slovak Republic – Bratislava. An individual is exempt from the accommodation tax if they are a student continuously preparing for their future profession through full-time study, up to the end of the calendar month in which their third-level (doctoral) higher education is completed.
